Wychwood, Oxford Guide to Safeguarding Requirements for other groups using the School Premises

The following policy is written with due regard to KCSIE 2020 Update - January 2021 (Post EU Exit) and Working Together to Safeguard Children, July 2020.

KEY PRINCIPLES

- All children have the right to be protected from harm.
- The prime concern at all stages must be the best interest and safety of the child.
- The intention of this policy is to ensure that appropriate action is taken immediately where it is suspected that a child is being abused.
- Early recognition of abuse may prevent serious harm to children and the break-up of families if professional help can be made available.
- Everyone who comes into contact with children has a role to play in safeguarding them. School and other staff are in a position to identify concerns early and to provide help for children to prevent concerns from escalating.
- All staff must act in the best interests of the child.
- However, should staff feel that their safeguarding concerns are not likely to be taken seriously or who do not feel able to raise concerns regarding child protection failures with their Designated Safeguarding Lead or have concerns about the way a concern is being handled by their organisation then they should contact the NSPCC whistleblowing helpline on 0800 028 0285 or help@nspcc.org.uk
- A child is taken to be any person under the age of 18.

- Keeping Children Safe in Education (KCSIE) (September 2020)
- Boarding Schools National Minimum Standards (2015)
- Local inter-agency procedures published by the Oxfordshire Safeguarding Children Board (OSCB, which is the LSCB for Oxfordshire).

The School expects that all visiting staff should have regard to KCSIE when carrying out their duties to safeguard and promote the welfare of children and that this means they should comply with KCSIE (September 2020) unless exceptional circumstances arrive.

Wychwood, Oxford expects that every external organisation using the School's premises will have safeguarding procedures in place that comply with the requirements of Wychwood, Oxford's Safeguarding policy. To that end, Wychwood, Oxford will

- supply external organisations with electronic copies of Wychwood, Oxford's Safeguarding Policy
- supply external organisations with electronic copies of KCSIE 2020 Part 1 and Annex A
- require a signed declaration that all external staff will be made aware of and will comply with the requirements of the policy as if they were working at Wychwood, Oxford while in residence at Wychwood
- require documentation to show who is acting as the external organisation's Designated Safeguarding Lead together with proof that this person has undergone the required training to fulfil the role
- require documentation that proves all staff have been subject to an enhanced DBS check and Barred List check together with appropriate prohibitions, directions, sanctions and restrictions checks before they take up work within Wychwood's premises
- require documentation that proves all staff are trained in safeguarding prior to them beginning work within Wychwood's premises
